## Membership Commitment

The sustaining membership commitments are \$2,120.00 per year in addition to a one-time contribution to the Operating Endowment Fund. For those members who are age 29-35, the minimum standard commitment is \$1,060.00 per year, and Endowment Fund contribution of \$1,500.00 may be delayed until turning 36. There are no other assessments billed to our congregants, with the exception of fees for the Religious School. Membership is free for members who are under 29 years old.

If your resources permit you to take a part in the mitzvahs of promoting Jewish community, maintaining our beautiful place of worship and ensuring that Temple membership is available to all, I hope you will consider participating in a Sanctuary Giving Level Circle, see attached insert.

The payment, MADE PAYABLE TO BETH-EL CONGREGATION, should accompany the application for membership. The payment may be in the amount of one quarter, \$530.00, or for the full year of \$2,120.00. For those members who are age 29 to 35, the payment may be in the amount of one quarter, \$265.00, or for the full year of \$1,060.00. For convenience purposes, Beth-El Congregation accepts American Express, MasterCard, Visa, and Discover. The Operating Endowment Fund contribution of \$1,500.00 may be paid within a three-year period, or is reduced to only \$1,200.00 if paid in its entirety when you join.

Statements are sent to congregants on the following dates:

December 15	(Dues for 1/1 – 3/31)
March 15	(Dues for 4/1/ - 6/30)
June 15	(Dues for 7/1 – 9/30)
September 15	(Dues for 10/1 – 12/31)

Payments are DUE on the BEGINNING DAY of the billing quarter.

The Temple Board's policy is that a "Member in Good Standing" is one who complies with the above payment policy. Anyone who is more than two quarters in arrears will be subject to review by the Board of Directors concerning possible cancellation of membership.
